These members include lawyers, Judges, Barristers, arbitrators, experts, contractors, architects, engineers, quantity surveyors, insurers, students, and more.

The Society of Construction Law (SCL-India), is hosting the 3rd International Conference on Construction Law & Arbitration "*Construction Law 3.0: From Concrete to Code*". This one-day conference will bring together top experts in construction law and arbitration to explore the evolving legal landscape in India and beyond. For nearly a decade, SCL-India has been at the forefront of shaping conversations around construction law and arbitration in India. In its biennial conference held in New Delhi in 2017, the event featured 32 foreign speakers and 12 sitting judges. In 2019, the number grew to 49 speakers, including 9 sitting judges and 31 foreign speakers. The 2021 edition held virtually due to the pandemic hosted over 60 renowned speakers and around 400 global delegates. In 2023, the event welcomed over 60 speakers, including more than 25 foreign speakers and notably three sitting foreign judges. The 2025 conference boasted over 55 speakers, including 26 foreign speakers and 7 sitting judges from India and abroad. Meanwhile, the annual Mumbai conferences in 2024 & 2025 saw participation of over 35 Indian and Foreign Speakers and a delegate count close to 300 in each edition.

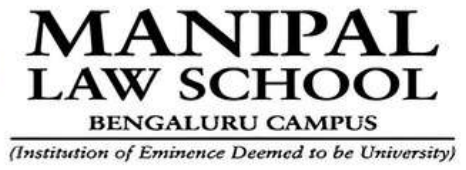


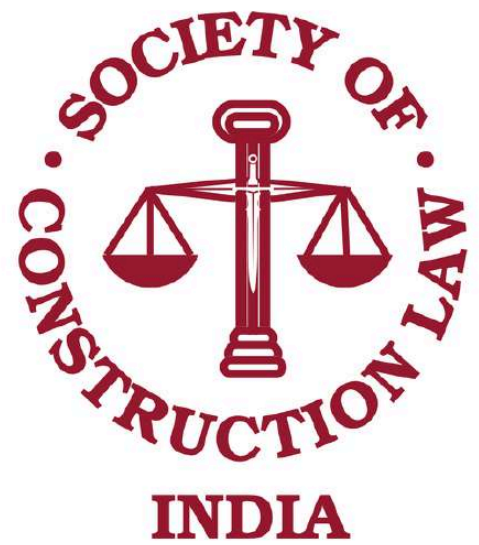
